Good News! Recall of Gov Newsom failed.

**Title 42 exclusion**—ACLU sued the Federal Government so they would stop using Title 42 as a way to exclude those seeking asylum. The Biden administration has 14 days to stop using it for families. It will still be allowed for adults without kids under Covid rules. The Biden administration is going to appeals court to fight it. They are currently using Title 42 against Haitian immigrants in TX.

**Less is More**—Good news is that Governor Horchul signed Less is More which limits mandatory detention for parole violations. The Rikers situation continues to be untenable with horrendous conditions. Many guards are not working so there's a big backlog in services. Limited access to food and medical care. Prisoners are locked in solitary for days to control them. There have been many suicide attempts.

Signing the Less is More act resulted in the release of several hundred people, but it doesn't go into effect until 2022. NY incarcerates people for parole violations at a higher rate than any other state.

#### Report backs:

#### 9.16—Immigration Action—Staten Island Ferry Terminal

Good demonstration last Thursday. It was well-received. Many liked the Welcome Afghan refugee signs. They were received on a bipartisan basis. Several passersby took photos.

Sept. 30 is the next one. May update signage for any changes in Title 42. One woman thanked the group. She was from Afghanistan; had been here for a while.

# 9.17--Enough is Enough—An Xr Action in Two parts—CD and March coinciding with the 10<sup>th</sup> anniversary of Occupy Wall Street

#### CD in the Morning

Incredible event; well done. More than 30 people were arrested. There was a march and a die in at three banks—Citi, Chase, B of A

At Citibank, 6 people were blocking the turnstile entrance where employees enter. Were there for 4-1/2 to 5 hours. Employees had to go through the freight entrance. Employees saw them coming down the escalator. Giant banner dropped. Brought in a small sailboat with people locked inside. Cops had to drill in and saw to get the people out. A complex action with a lot of different elements.

#### March in the Late Morning/Early Afternoon

March began at NYPL with a rally and speakers including—a little girl who was amazing. From NYPL to the UN; marched to where CDs were taking place. B of A had already moved people from the structure. 4 die ins were part of the march; we marched in the street. Ranged from 60 to over 100 at different points. Very good imagery.

## 9.17--Stand Up for Voting Rights—Federal Hall/26 Wall St. at 11 am

This was a small (~30 people) demonstration that was theatrical, colorful with some great speakers. Speakers included Grace Meng, Congresswoman from Queens, Jumaane Williams, NYC Public Advocate, and Susan Lerner, ED of NY Common Cause with Jawanza Williams of Vocal NY acting as MC. There were 2 or 3 news outlets taking photos and videos of the event. It was a spirited pitch to get the job done for voting rights.

## 9.17--Say Their Names—96th St. and Broadway at 5 pm

Gratified at the number of people. People didn't stay away because of the prior week's issues. Wanted to have an observer on each side of the street—Karin and Alex were the main observers this week. The group connected beforehand to center themselves. The space was held and it was a calm experience. We are moving toward becoming a performance space and will need to examine that but for now it's good.

#### 9.17--Chuck the Filibuster Chalking across from 9 PPW at 6:30 am

A small group of 5 RARers met across the street from Schumer's apartment building and wrote CHUCK THE FILIBUSTER in the bike lane in huge letters spanning 100 feet.

Still there after the weekend, albeit a bit faded this morning/Tuesday. Need to do more to get pics on social media. Schumer was there while we were doing it so we think he knows about it. Something we can do fairly cheaply in about 45 minutes. Could be a technique for other issues. Need to get the best shot of it on RaR's twitter account. It's up on INBK's twitter.

#### 9.20--Vaccine Access Demo near the UN at noon

Anticipated about 50 but had somewhere between 50 to 100 people.

Everything was closed off; police barricades everywhere. Couldn't get into Dag Hammarskjold Plaza. Gathered on the sidewalk instead. Started with a couple of speakers. Held tombstones. Held a Public Citizen banner which spanned 2nd Ave. And did a die-in. The banner said

"Millions are dying. Vaccinate the world now". Many showed up from international health groups. Several RaR marshalled. Short, sweet, successful, got photo ops. Wanted to put out a narrative before Biden spoke at the UN.

One critique of this action—Marshals were there to block traffic but the banner should have been right in front of the traffic, no on the other side of the street. This was not a good use of marshals.

From the NYT article: "On Monday, activists staged a demonstration near the U.N. headquarters in New York calling on Mr. Biden to "end vaccine apartheid." A coalition of nearly 60 human rights and other advocacy groups sent Mr. Biden a letter urging him to back a \$25 billion investment that would produce eight billion doses within a year — and to ask Congress to include a specific line item for it in the \$3.5 trillion "Build Back Better" budget legislation that lawmakers are now considering.
