#### **REPORTBACKS**

Stop the attacks on Alexandria Ocasio Cortez, Ilhan Omar, Ayanna Pressly, and Rashida Tlaib, July 31 at Trump Tower, (Jamie)

I had come to the floor a couple weeks ago to bring a T shirt saying "Stop the attacks on: Alexandria Ocasio Cortez, Ilhan Omar, Ayanna Pressly, and Rashida Tlaib. 24 people entered Trump Tower.

The goal of this demonstration was to press the limit on what we could do in Trump Tower. We lined the inside of Trump Tower which made guards and Secret Service quite anxious. Stood in the lobby, up and down the escalator, went into the gift shop. We spent a half an hour.

**Impeach Action** at the Trump Hotel and Tower Monday, August 5th, 5:30 pm

20 people arrived at 5:15 for a 5:30 demonstration; we had 75 human beings. What i s happening is that more people are coming from off the street to join, learn what we are doing, and become engaged.

While we were half-way through the demonstration, "Sing Out Louise" came

Sean (rep. From Sing Out Louise) - we focused primarily on the Trump-oriented songs that make fun of the far right

Umbrellas that spell-out "I-M-P-E-A-C-H"

Member comment from Susan: Concern with some of the words that Sing Out Louise sings, "Whore" and "Ho" "Putin's Bitch" due to sexism. I find these words sexist and harmful. I spoke to Mark, who works with Sing Out Louise, and then I expressed saying "I have a problem with these words." Susan felt dismissed by the organizers of Sing Out Louise.

Martin: Comment - - Generally Sing Out Louise was well-received by the crowd, and many people said when Sing Out Louise sang, they felt like the action felt less inclusive to the wider public and passers-by. I would like to communicate better with Sing Out Louise about coordinating on these actions, and addressing concerns about these lyrics.

Rick: Comment - - Question - - on how many cards were given out - almost 400 cards (Impeach, Rise + Resist cards)

Member Comment: I sometimes think that Sing Out Louise Fellini-esque. Our immigration silent vigils have been really silent and compelling; I participated in the t-shirt action, and something about yesterday's action felt "off." and given the atrocities from over the weekend (two shooting massacres in TX and OH) made the action feel "off" and made the tone feel particularly problematic and circus-like.

Additional concern about a single Trump supporter who was very intrusive to the action.

Andy - Comment: I want to validate Susan sharing her concerns. One idea is that we might let Sing Out Louise know that if we are working on an action with them that we might request that there are songs that they not sing. I have a broader concern about the tonal mismatch between what we are sometimes trying to accomplish with our actions and what Sing Out Louise brings. When we were doing the nationally organized Mueller obstruction-of-justice protests, we started with a stage and speakers in Times Sq., and Sing Out Louise opened that event, and feedback received from that event was that Sing Out Louise is really polarizing - - People either love it, or feel like it's out of place.

Rebecca - Comment: I want to validate what Susan said; it seems like if they (Sing Out Louise) are going to be joining in these actions there is no reason for them to use language that is sexist or offensive

Mike - Comment: I almost went to the GAG Rally at Grand Army last night. In this case, it is the kind of thing that the Emergency Response team could try to shift actions and combine forces in response to the horrific events of the weekend. There are a ton of lyrics, too, that are cold-war sounding on Russia, and I think nationalism is a problem, and the problems of the lyrics politically: It is clear to criticize Trump for his racism, corruption of corporate power, and relationship with Putin

Alexis: Let's take time to communicate with our partner organization so we can move forward and be more collaborative and productive in our actions.

**Elevators are for Everyone** Action August 1st, in front of the NY Supreme Courthouse, Jennifer reporting

Rally out front with coalition organizations, seeking a legally binding agreement for 100% accessibility in the NY Subway system

After the rally we went into the courtroom to hear Judge Hagler as he navigates with the MTA lawyers and disability rights advocates representing the plaintiffs. Pushes for transparency from Judge Hagler; Plaintiffs are seeking documents that are not redacted, and Hagler said, "Let the sun shine in," however, the press have witnessed that Hagler stated that he understands that elevators are expensive.

Bottom Line: MTA has 2 months more time to share all paperwork with disability rights advocates, and there will be another hearing in November on how this case will proceed.

**GAG** Action in Times Square, August 4th (Jay)

When the El Paso shooting happened late Saturday morning, August 3rd, whenever there is a Mass Shooting, GAG calls upon ourselves to hold some kind of rally or march within 24-48 hours of the news being reported, so we spent all day on Saturday seeking to reach out to our partner organizations, our members, and Rise + Resist to put together an action regarding El Paso; the action was actively being organized while the news of Dayton

We gathered at the steps of the NYPL; GAG Put our Human Beings Together - - Human Beings are folks who are all dressed in white, are veiled, and hold a placard, representing a person who has been killed by gun violence.

As this happened so soon after the violence in El Paso and Dayton, we did not have all of the names of those who died as a result of the violence in those cities. The veiled individuals at the event this time, then, represented a mix of individuals who have died as a result of gun violence.

**ERT - Emergency Response Team** of Rise and Resist; if an action comes up between Tuesday meetings, the ERT of R + R makes a decision on behalf of the body, and then at the next meeting, R + R can vote on whether to endorse an action.

Andy - Comment: Bad faith arguments from Republicans following the violence of the weekend; Trump's comments about the involuntary commitment or incarceration of people who are mentally ill; and there are concerns from disability rights advocates about this language. Concerns about the "painting" of the Dayton shooter as a "violent anti-fascist shooter" and concerns about the ethos o

Member question: Are images of the guns that have been used as a part of these attacks ever used in the displays of GAG events?

Jay: No - we see that as glorifying and normalizing gun violence.

**No Raids/Close the Camps - Abolish ICE - Silent Demonstrations** August 15, 5:30 at the Staten Island Ferry Terminal in Manhattan

**No Raids/Close the Camps - Abolish ICE - Silent Demonstrations** August 29th, 5:30 in Grand Central Terminal's main hall

Silent demonstrations, quite serious. We have very large banners that read:
No Raids
Close the Camps
Abolish Ice

We also display photos of the camps, and photos of those who have died in custody.

The Staten Island Ferry Terminal is a new location

Vigils previously were approximately 40 people in attendance; since early July, numbers in attendance have grown to approximately 200 people in attendance (in July actions at the Grand Central Terminal and in the Oculus).

We are seeking spaces for demonstrations where a large number of people will be congregating at the end of the workday.

We are trying to go to as many of these large public spaces where we can find a large number of people at the end of the day. If anyone has any ideas, we would love to get people at the end of the day.

Comment: You should probably check on the permitting for the Staten Island Ferry Terminal

Jamie: The place we are scoping out is at the plaza between the Terminal and the subway station. The area is the outdoor open plaza, and only if it were really inclement weather would we consider going inside. We don't know how we will set up there, but we will assess based on how many people we have there.

Member Comment: I would suggest Pier 11, where people go to the Rockaways; as well as Penn Station.

Member Suggestion: Harlem

Member Suggestion: Jamaica Transportation Hub or an Airport, or a downtown park for an action.

Suggestion: Barclays Plaza to demonstrate; and Barclays Center is owned by a Trump supporter
